Information about the Embassy Of India, Tehran required under section4(1)(b) of the right to information act, 2005

(i)	The particulars of its organization, functions and duties;	The Embassy is headed by Ambassador of India and has various wings, namely, (a) Administration Wing; (b) Consular Wing; (c) Commercial Wing; (d) Political Wing; (e) Military Wing; and (f) Naval Wing. The Embassy functions within the purview of business allocated to the Ministry of External Affairs under the Government of India Allocation of Business Rules and Transaction of Business Rules. The functions of the Embassy inter alia include bilateral political and economic cooperation, trade and investment promotion, cultural interaction, press and media liaison, and consular operations including PIOs/NRIs, etc.
